## **REGISTRATION IS REQUIRED FOR NEW BUS STUDENTS**

To ensure bus service and route selection, parents must register child(ren) before transportation will be provided.

- 1) Application for Transportation within the community of \_\_\_\_\_. This helps the transportation department figure out which community the student belongs to.
- 2) Parent /Guardian Name, helps the transportation department when looking up students to ensure we have the correct student in our system.
- 3) Mailing address allows the transportation department to mail any important documents or bus schedules if required.
- 4) Telephone numbers allows the transportation department and the bus driver to contact the parent/guardian in the event of an emergency, bus cancellation or route changes.
- 5) Street Address, Municipal Address or Legal Land Location is required for funding from Alberta Education. *Box numbers are not accepted.*
- 6) Legal Name of student is required for funding from Alberta Education.
- 7) Date of Birth, allows the transportation department to ensure we have the correct student in our system.
- 8) Grade is required for funding from Alberta Education.
- 9) School to be attended is required for funding from Alberta Education.
- 10) Current Rider tells the transportation department if the student moved or is a new student
- 11) Route number tells the transportation department what bus route the student is riding on (can be found at school)
- 12) Current siblings/students at the stop allows the transportation department to copy the information from one student to the new student.
